

Terms & Conditions

Port City 'Staycation' Promotion

1. This promotion is conducted by **Port City Bowling Club Ltd**
2. Entry is open to **financial members of Port City Bowling Club** aged **18 years and over**.
3. The promotion commences at **5pm Wednesday 29th April 2026** and concludes at **7:00pm on Friday 26th June 2026** ("Promotional Period"). Entries received outside this period will not be accepted.
4. To be eligible for the **Major Prize Draw**, participants must complete **all ten (10) passport activities** during the Promotional Period and place their completed passport in the barrel located in the Club's foyer entry
5. Each passport activity is subject to receive 1 x stamp to be placed on the relevant item by staff upon completion of transaction only
6. Passports that are incomplete, illegible, altered, lost, or tampered with will be deemed **invalid**.
7. The **Major Prize Draw** will take place at **7pm on Friday 26th June 2026** at **Port City Bowling Club**, via public PA from the valid entries placed in the barrel during the promotion period.
