

Port City's Great Northern Father's Day Promotion

Terms and Conditions

1. Promoter

The promoter is Port Macquarie City Bowling Club Limited, trading as Port City Bowling Club, of 4 Owen Street, Port Macquarie NSW 2444 ("the Promoter").

2. Promotion Period

The promotion commences at 9:00am AEST on Saturday, 1 August 2026 and closes at 6:00pm AEST on Sunday, 6 September 2026 ("Promotion Period").

Entries received outside the Promotion Period will not be accepted.

3. Eligibility

Entry is open to current financial members of Port City Bowling Club who are aged 18 years or over.

Directors, management and employees of the Promoter are not eligible to enter.

The Promoter may request proof of age, identity and current membership before validating an entry or awarding the prize.

4. How to Enter

To receive one entry into the promotion, an eligible member must, during the Promotion Period:

1. Purchase one Great Northern Super Crisp pint or schooner from a participating bar at Port City Bowling Club; and
2. Present their valid Port City membership card at the time of purchase and complete the entry process as directed by staff.

One qualifying purchase entitles the eligible member to one entry.

Multiple entries are permitted, provided each entry results from a separate qualifying purchase and complies with these Terms and Conditions.

Purchases must be made in accordance with the responsible service of alcohol requirements and policies of Port City Bowling Club. No purchase or entry will be accepted where service has been refused.

5. Prize

There is one major prize to be won, consisting of the Ultimate Port Cup Day Out for six people, including:

- A table for six people at the live Big Sports Breakfast event at Port City Bowling Club, including buffet breakfast served from 7am. Breakfast excludes barista coffees.
- Courtesy bus transport for the winner and their five guests from Port City Bowling Club to Port Macquarie Racecourse after the racecourse gates open at approximately 11:00am;

- Entry for six people to the 2026 Carlton 3.5 Port Macquarie Cup CharBar Luncheon at Port Macquarie Racecourse;
- A three-course luncheon for six people;
- One drink on arrival per person; and

The prize is valid only for the scheduled 2026 Big Sports Breakfast and Carlton Dry 3.5 Port Macquarie Cup events and must be redeemed on the applicable event date Friday 9th October 2026.

6. Prize Conditions

The winner and all five guests must be aged 18 years or over.

The winner must attend the events to redeem the prize.

The prize does not include transport to Port City Bowling Club before the Big Sports Breakfast, return transport from Port Macquarie Racecourse, accommodation, additional beverages, additional meals, wagering expenses or any other personal expenses unless expressly stated.

The courtesy bus will depart at a time determined by the Promoter. The winner and guests are responsible for being ready at the advised departure time. The bus will not be delayed for late guests.

Event admission is subject to the conditions of entry, dress regulations, responsible service of alcohol requirements and codes of conduct imposed by Port City Bowling Club & Port Macquarie Race Club.

The prize is not transferable, exchangeable or redeemable for cash. No part of the prize may be sold, transferred or substituted by the winner.

7. Prize Draw

The prize draw will take place at approximately 6:00pm AEST on Sunday, 6 September 2026 at Port City Bowling Club, 4 Owen Street, Port Macquarie NSW 2444.

The winner will be selected at random from all valid entries received during the Promotion Period.

The winner is not required to be present at the draw.

The Promoter's decision is final, and no correspondence will be entered into.

8. Winner Notification

The winner will be announced in the Club premises at the time of the draw.

The provisional winner will be contacted if not present at the time of the draw using the details recorded on their Port City membership

The winner must provide valid identification, proof of age and proof of current membership before the prize is awarded.

9. Claiming the Prize

The winner must claim the prize by the deadline advised by the Promoter.

If the provisional winner:

- Cannot be contacted;
- Does not claim the prize by the advised deadline;
- Is unable to attend the scheduled events;
- Does not satisfy the eligibility requirements; or
- Is otherwise found to have breached these Terms and Conditions,

the winner will forfeit the prize and the Promoter may conduct a redraw from the remaining valid entries.

10. Event Changes or Cancellation

The prize is subject to the Big Sports Breakfast and the 2026 Carlton Dry 3.5 Port Macquarie Cup proceeding as scheduled.

The Promoter is not responsible for any postponement, cancellation, interruption or change to an event due to weather, venue requirements, government directions, safety concerns or any other circumstance outside the Promoter's reasonable control.

Where any component of the prize becomes unavailable, the Promoter may substitute it with another component of equal or greater value, subject to any applicable legal requirements.

The Promoter will not provide cash compensation for any cancelled, postponed or unused component of the prize.

11. Responsible Service of Alcohol

Alcohol will only be served to persons aged 18 years or over and in accordance with applicable liquor laws and the responsible service of alcohol policies of the relevant venues.

The Promoter and participating venues reserve the right to refuse service, remove a person from the venue or cancel their participation in the prize where that person is intoxicated, disorderly, abusive or otherwise fails to comply with venue requirements.

The winner and guests are responsible for arranging safe transport following the race-day event.

12. Invalid Entries

The Promoter reserves the right to verify the validity of entries and disqualify any entrant who:

- Submits an entry that is incomplete, inaccurate or fraudulent;
- Tampers with the entry or draw process;
- Uses another person's membership card;
- Fails to comply with these Terms and Conditions; or

- Engages in conduct that may damage the reputation of the Promoter, Port Macquarie Race Club and Great Northern/ Asahi Beverages.

Entries generated through fraud, computer error, technical malfunction or improper conduct will be deemed invalid.

13. Liability

To the extent permitted by law, the Promoter is not responsible for any loss, damage, injury, delay or additional expense suffered by the winner or their guests in connection with entering the promotion, accepting the prize, travelling to or from an event, or participating in any prize activity.

Nothing in these Terms and Conditions excludes any rights or remedies that cannot lawfully be excluded under the Australian Consumer Law.

14. Privacy

Personal information collected in connection with the promotion will be used to administer the promotion, verify entries, contact the winner and award the prize.

The Promoter may disclose relevant information to event partners, prize suppliers, regulatory authorities or service providers where reasonably required to administer the promotion or comply with the law.

Personal information will otherwise be handled in accordance with the Promoter's privacy policy.

15. General Conditions

By entering the promotion, entrants confirm that they have read, understood and agreed to these Terms and Conditions.

The Promoter reserves the right to modify, suspend, cancel or terminate the promotion if circumstances outside its reasonable control prevent the promotion from being conducted fairly or as intended, subject to applicable laws and regulatory requirements.

This promotion is subject to the laws of New South Wales, Australia.
